LOCAL ADMINISTRATIVE ORDER 1999-2

IT IS HEREBY ORDERED that the 35th Judicial District Court will adopt the following Guidelines for Unscheduled Court Closing Due to Weather Emergency.

The 35th District Court is funded by 5 municipalities, each with individual policies concerning emergency weather closing. It is therefore necessary for the Coudevelop its own policies concerning weather closing.

Regular Court hours for the 35th Judicial District Court are Monday through Friday from 8:30 a.m. to 4:25 p.m. except legal holidays as posted annually.

The Chief Judge or Court Administrator will determine if there is a weather emergency sufficient to close the Court.

The Chief Judge or the Court Administrator shall notify the five communities the decision to close and/or dismiss Court employees concerning emergency weather closing. It is therefore necessary for the Court to

Friday from 8:30 a.m. to 4:25 p.m. except legal holidays as posted annually.

The Chief Judge or the Court Administrator shall notify the five communities of the decision to close and/or dismiss Court employees.

In view of the different practices within the five communities and the collective bargaining agreements governing Court employees, the Court shall charge time off in a manner consistent with the collective bargaining agreements.

The decision to close will be announced to employees and all appropriate law enforcement agencies. Public notice will be made by posting notice(s) on the public entrances to the Courthouse and delivering public service announcements over local radio and/or television stations.
